Step 1

Your doctor completes the Patient Enrollment Form

Step 2

APDS Assist processes your Enrollment Form

- What is in the packet?
 - Enrollment Form, which is also your prescription
 - Patient Consent Form to access all support services
 - If you didn't sign this yet, don't worry. You can take care of that in Step 3 when you chat with your APDS Assist Care Coordinator

- An APDS Assist Care Coordinator will reach out to you and/or your doctor if more information is needed

Your APDS Assist Care Coordinator connects with you for your Welcome Call

- Your APDS Assist Care Coordinator will introduce themselves and talk about their role in your journey with Joenja
- Discuss the Patient Consent Form, if not already received by APDS Assist
- Discuss your insurance coverage
- Schedule your Starter Program and Welcome Kit shipment, if eligible
- Your APDS Assist Care Coordinator will be working behind the scenes with your doctor's office if your insurance requires prior authorization

Your dedicated APDS Clinical Educator reaches out

- Your dedicated ACE is here for one-on-one education, clinical support, and resources for you, your family, and your caregiver during your journey with Joenja
- Will review and assist with clinical resources such as the My ID profiles and Family Tree Mapping
- Note, ACEs do not offer medical or treatment advice or replace discussions with a doctor

Your APDS Assist Care Coordinator reaches out to you once your prescription for Joenja is approved to ship

- Discuss your out-of-pocket cost and support programs available to you
- Provide you the opportunity to speak with the APDS Assist Specialty Pharmacist if you have any questions
- Schedule the shipment of your Joenja

Continued outreach during your journey from APDS Assist

- APDS Assist Care Coordinator will call you when it is time for a refill
- ACE will continue to reach out and be a supportive advocate for you and your family

APPROVED USE

JOENJA® (leniolisib) is a prescription medicine that is used to treat activated phosphoinositide 3-kinase delta (PI3Kδ) syndrome (APDS) in adults and children 12 years of age and older.

IMPORTANT SAFETY INFORMATION

Tell your healthcare provider if you are pregnant or plan to become pregnant. JOENJA may harm your unborn baby. Your healthcare provider will do a pregnancy test before you start receiving JOENJA.

Use effective birth control to prevent pregnancy while taking JOENJA and for one week after you stop taking JOENJA. If you plan to become pregnant, continue taking your birth control for one week after stopping JOENJA. Talk to your doctor about what type of birth control method is right for you while taking JOENJA.

It is not known if JOENJA passes into your breast milk. Talk to your doctor about the best way to feed your baby if you take JOENJA.

Tell your healthcare provider and pharmacist about all the medicines you take, including prescription and over-the-counter medicines, vitamins, and herbal supplements. JOENJA and certain other medicines may affect each other.

Tell your healthcare provider if you are scheduled to receive an immunization (vaccine). JOENJA may affect how well a vaccine works.

Discontinue JOENJA and seek immediate medical attention if you develop any signs and symptoms of serious allergic reactions including itching, skin redness, hives, rash, difficulty breathing, or swallowing.

The most common side effects of JOENJA include headache, inflammation of sinuses, weight gain, and dry, itchy, and inflamed skin (eczema). These are not all the possible side effects of JOENJA. Tell your healthcare provider about any side effect that bothers you or does not go away.
